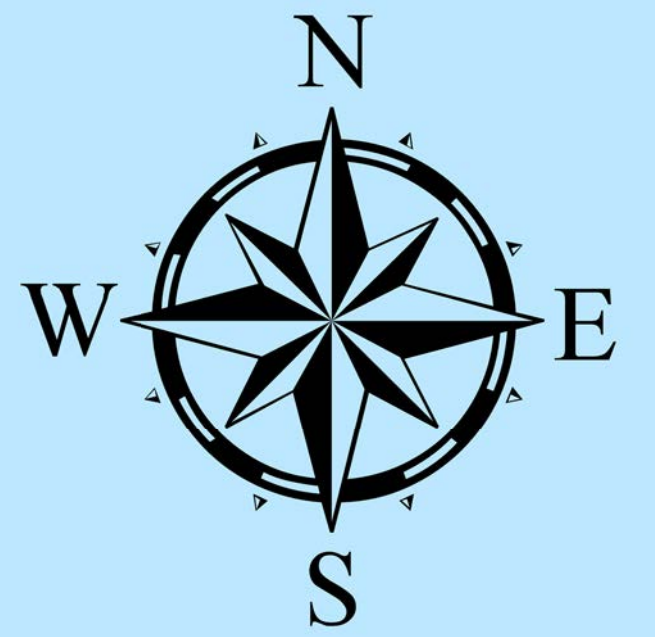

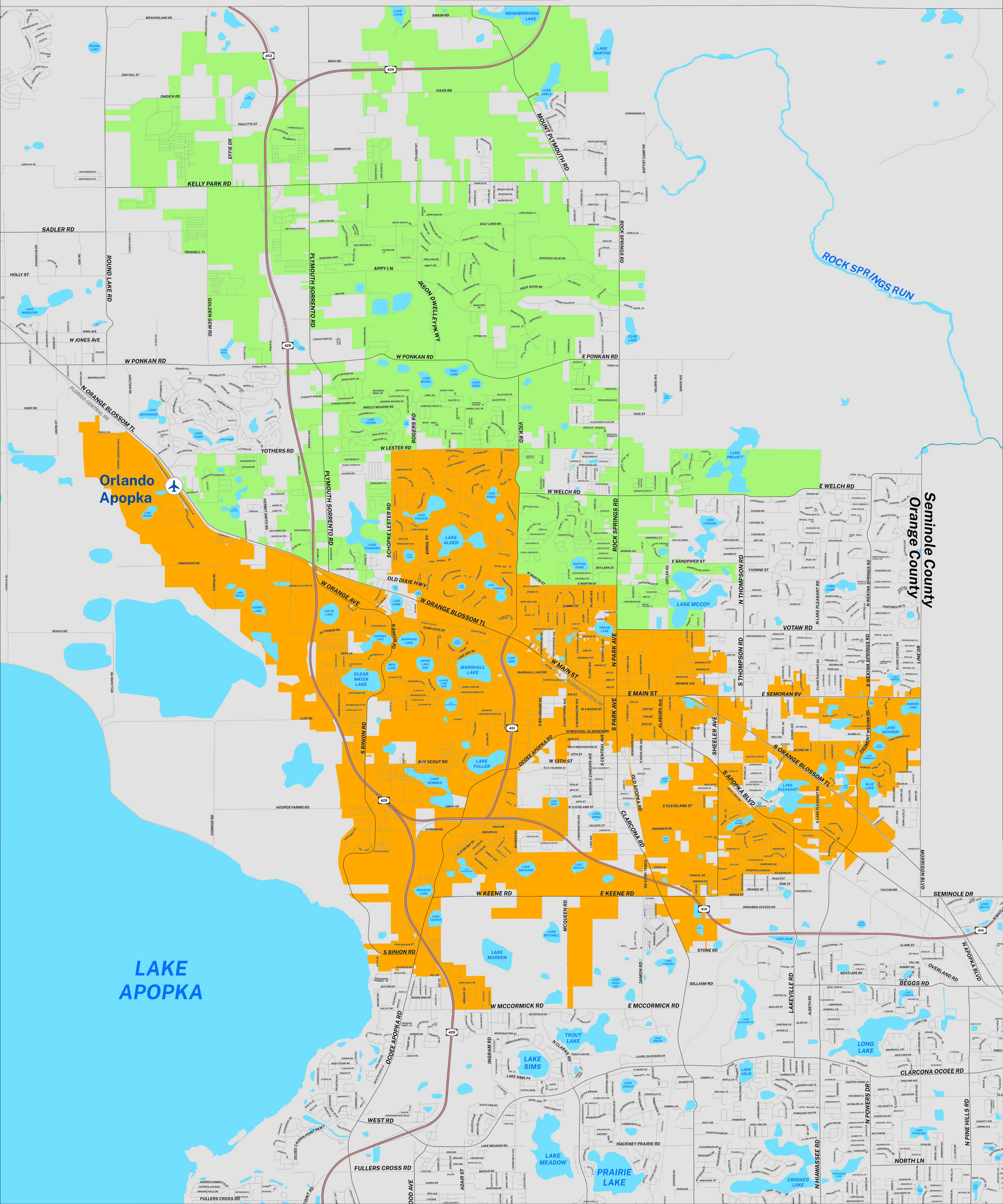

The City of Apopka in Orange County, Florida contains two municipal precincts AP01, Legacy Precinct (9104) and AP02, Legacy Precinct (9204).

Municipal precinct AP01 northern boundary follows along North Orange Blossom Trail, West Orange Blossom Trail, Old Dixie Highway, School Street, Schopke Lester Road, West Lester Road, Vick Road, Martin Street, North Park Avenue, Votaw Road, west of South Thompson Road and East Semoran Boulevard. The western boundary follows along Wesley Road, southwest of Orlando Apopka Airport, southwest of Hogshead Road, Conrad Road, extends to Lust Road and runs west of South Binion Road. The southern boundary follows along Stillwater Avenue, Hill Drive, 1st Street, SR-429, West McCormick Road, east of Apopka Ridge Circle, north of Rory Oak Circle, eastern shore of Lake Carter, West Keene Road, McQueen Road, West McCormick Road, East Keene Road, Clarcona Road, Honeycomb Lane, Stone Road, SR-414, Grove Street, Sarasota Avenue, Wildwood Street, south of Windsor Oak Drive, Greenacre Road, south shore of Blue Lake, Wheeler Road, Concourse Road. The eastern boundary follows along the Seminole/Orange county boundary.

Municipal precinct AP02 northern boundary follows along the Lake/Orange county boundary, southern shore of Neighborhood Lake, Swain Road, SR-429, SR-453, Irrgang Ranch Road, Ondich Road and extends to Round Lake Road. The western boundary follows along Kelly Park Road, Golden Gem Road, Trussell Trail, West Ponkan Road, SR-429, Yothers Road and extends to North Orange Blossom Trail. The southern boundary follows along North Orange Blossom Trail, West Orange Blossom Trail, Old Dixie Highway, School Street, southern shore of Lake Standish, Schopke Lester Road, West Lester Road, Vick Road, Martin Street, North Park Avenue and extends to Votaw Road. The eastern boundary follows along North Thompson Road, East Sandpiper Street, Ustler Road, East Welch Road, runs through the center of Lake Prevatt and runs parallel north of Cedar Glen Drive. The eastern boundary continues along Rock Springs Road, Mount Plymouth Road, extends through the center of Lake Lerla and west of Lake Bartho.
